ITFA, Aug 30, Dehradun: As the world witnessed Communist China's approach of twisting with truth and facts - whether it be the forceful subjugation of Tibet or the wrapping up of Covid-19 pandemic, it has led to an unforeseen angst against the totalitarian regime of Chinese Communist Party. In addition to this, the recent military skirmishes at Indo Tibet border between Indian and Chinese armies has

impinged the Indian Prime Minister, Sh. Narendra Modi to have clearly conveyed the message from the ramparts of Red Fort at 74th anniversary of India's independence that from LOC to LAC, from Terrorism to Communism Indian forces has dealt the enemies with equal proportionate language as it is befitting. In the public domain, both at rural and urban community, the Indians have come together to voice their solidarity against the injustices and cruelties that Communist China has given birth to its neighbor including India and Tibet. Since the beginning of July, series of webinars were organized to expose the truth behind those injustices of Chinese Communist Government Indian Tibet Support Groups in India irrespective of their ideological differences. In this line, an autonomous body of Bharat Tibbat Maitri Sangh was formed on 20th July 2020 under the convenorship of Dr. Ram Chandra Upadhaya. At his call, ITFA organized its first meeting on 30th August 2020 at Party Office of Bharat Antayaudaya Party (BAP) at Preet Vihar, Indira Gandhi Marg, Niranjanpur, Dehradun. The meeting was conducted by Dr. Ram Chandra Upadhaya, Convener, ITFA under the chairmanship of Sh. Balbir Talwar, President, BAP. He lamented about the future expectations of Tibetans in exile and urges the Indian community to extend every possible cooperation in the days to come. Sh. Balbir Talwar, President, Bharat Antyanudaya Party, also founding member of ITFA, reaffirmed his commitment for the justice of Tibet to be prevail with certainty. He asked the members reinforce the resolution that was adopted during the meeting to be informed to all the concerned members with conscience. The meeting ended with a resolution addressed to Prime Minister of India that; His Holiness the Dalai Lama must be conferred with Bharat Ratna at the earliest possible; Panchsheel Marg in New Delhi shall be replaced with Dalia Lama Marg

His Holiness the Dalai Lama must be invited to address the Indian Parliament of Joint Session. Sh. J. S. ITCO, Aug 31, Dehradun: Mr. Tsultrim Dorjee, Tibetan Welfare Officer, Doeguyugyaling, Herbertpur and Mr. Jigmey Tsultrim, Coordinator, ITCO was called upon by Dr. M. K. Otani, Expert Advisor to the Government of India, Ministry of Culture, Government of India, at the latter's camp office at Tons Colony, Dakpathar, Dehradun, Uttarakhand. As it was not expected, while discussing about the ways to strengthen Indo Tibet relations and interactions at the region, Mr. Tsultrim Dorjee referred about Dr. M.K.Otani and his associations with the settlement in the past. However, Mr. Tsultrim himself had not possibly able to meet him owing stretched engagements at his table and outside. Suitably it could be that it was then decided to meet him, reflecting upon the cause and state of urgency that Tibetan freedom struggle is moving through. At the outset, Mr. Tsultrim Dorjee greeted Dr. M. K. Otani with a Tibetan traditional scarf and expressed his gratitude for being supportive and sympathetic of Tibetan

community in large and particularly in Herbertpur and near around. Mr. Tsutlrim also shared him about his experience as a Tibetan Civil Servant, being able to serve at different terrain from 2500m to 150m above sea level with its distinct culture and ethnicity over the last more than three decades. ITCO Coordinator explained the inception of ITCO, its achievement during the years and challenges ahead of coming years. He insisted upon drawing mutual programs that would enable both the communities to understand the course of Tibetan movements in India and elsewhere. Dr. M. K. Otani, inked his observation and experience about the mannerism and non-assimilation of larger Tibetan people towards Indian Buddhist people which then creates empathy and miscommunication. Dr. Otani also emphasized upon the need of more awareness of existence and relevance of Indian Buddhist people amongst Tibetan communities especially Tibetan youth and Buddhist centers in India. He expressed his deep reverence towards His Holiness the Dalai Lama for being the torch bearer of Nalanda tradition of Buddhist studies that stems out of India and spread over various part of world. Furthermore, he shared about his personal background of being a Theravada Buddhist practitioner and his marriage to Ms. Namgang Dolma, a Buddhist Khampa woman who hails from Uttarkashi, Uttarakhand. He also shared about his experience of relevance of Buddhist wisdom which is key to every social phenomenon to aspire ultimate peace and harmony. Dr. Otani, stressed the need to work closely upon the joint efforts of not only preserving the values of Buddhist teachings but also to safeguard the aspirations of Tibetans in exile - its identity.



The members decided to organize an awakening program on Tibbat Mukti Sadhana and liberation of Indian territory from Chinese Occupation from 20th October to 20th November, 2020 (period of Chinese attack on India in 1962). They also decided for campaign to aware different political parties and ensure their support for Tibetan Cause during Bihar Assembly Election in Sept-Oct. 2020. Mr. Jigmey Tsultrim, Coordinator of India Tibet Coordination Office, Delhi also addressed the webinar and gave suggestions to strengthen the organisation and its programmes for Tibbat Mukti Sadhna. Dr. Harendra Kumar presented the concluding remarks and Shri Prabhat Kumar gave the vote of thanks to all for their participation.
